- 1- Ambulances Braun Northwest /Liquid Spring Suspension
 - There have been multiple comments about the ambulance ride being quite bumpy. Chief would like to do a retro-fit for Ambulance 13-1, and it will be approximately \$13,000.
 - Commissioner Dalessandro made a motion to approve the retro-fit for Ambulance 13-1 for the amount of \$13,000. Commissioner Hutchins seconded the motion and the motion passed by unanimous vote.

2- Roofing

• A-1 Roofing came to assess the roofing and its status. After that assessment, Chief Rux would like to do a bid spec process for station 13-1 right away. He would be looking for a 30 year composite. More information will be provided at the next board meeting.

3- Strategic Planning

• Chief Rux wanted to inform the Board that both him and the Office Manager met with Commissioner Dalessandro to discuss the Strategic Planning, and will be meeting regularly to continue working on that throughout the rest of the year.

NEW BUSINESS

- 1- Stairmaster Purchase
 - The Chief informed the Commissioners that the department would like to purchase stairmaster machine. The cost for a used one, with 1 year warranty/3 yr limited warranty, is about \$5,900.
 - Commissioner Dalessandro made a motion to approve the purchase of the stairmaster machine for the amount of \$5,900. Commissioner Hutchins seconded the motion and the motion passed by unanimous vote.
- 2- Executive Session RCW 42.30.110(1)(g) To evaluate the qualifications of an applicant for public employment.
 - The Commissioners then met for an executive session at 12:39pm for approximately 15minutes. The meeting resumed at 12:54pm, and no action was taken during the executive session.
